#### **Briefly describe the rationale for disestablishment:**

In 2014-15, the BS in Health Education and Health Promotion was created to replace the concentration and give students a greater grounding in the areas they must have to gain certification as a Certified Health Education Specialist upon graduation, which is a certification needed to be widely employable in this field.

## **Impact on other existing programs:**

## **Impact on current students:**

There are 100 total students at this point according to the retention dashboard at ASU. Of those, 64 are seniors, many who have applied to graduate in spring 2015; 30 are juniors, who should graduate by May 2016. There are 5 sophomores and 1 freshman who has not yet been contacted and changed to a new major. Any student who was admitted for fall 2015 is being changed to another major at orientation. No changes of major are being accepted. There are another 28 still at the community colleges in a MAPP or TAG. We will contact each of those students who have not yet matriculated to ASU and have them sign up for the new MAPP in Health Education and Health Promotion or another related degree of their choice. If they sign up for the MAPP in Health Education and Health Promotion, they will not be disadvantaged, since the early courses are almost identical; there is only one additional course on the MAPP in Health Education and Health Promotion. We would like to freeze the ability for students at the community colleges to sign up for MAPP in Exercise and Wellness (Health Promotion), BS.
