## Briefly describe the rationale for disestablishment:

Due to the changes in hiring for personnel in the Air Traffic Control segment of aviation, it will be more beneficial for students to have a BS in Aeronautical Management Tcchnology, with a concentration in Air Traffic Management. Students in the current BS approached the department with concerns regarding the name of the degree only reflecting the Air Traffic Management portion of the curriculum. The faculty of the Air Traffic Management program met over the course of the summer and fall semester, and determined that this would be a beneficial change. Information was pulled from other programs, current industry hiring standards, and FAA guidelines.

We are proceeding with two proposals simultaneously, the first is the creation of the BS in Aeronautical Management Technology (Air Traffic Management), and the second is the disestablishment of the BS in Air Traffic Management. If the creation of the BS in Aeronautical Management Technology (Air Traffic Management) is approved, we will then proceed with this proposal to disestablish the BS in Air Traffic Management. The information below is predicated by both proposals being approved.

The 88 current students will not be impacted with the disestablishment of this program. The newly established concentration in Air Traffic Management will consist of the same courses as the current BS in Air Traffic Management. Once the new program has been approved, students will no longer be able to graduate with the BS in Air Traffic Management degree. We will move current students to the new BS in Aeronautical Management Technology with a concentration in Air Traffic Management as this designation on their diploma will enable them to secure Air Traffic as well as other aviation job opportunities. We will also have all newly admitted students moved to the new concentration in Air Traffic Management. Students will be notified via asu.edu email regarding the change. Also, all faculty teaching in the Air Traffic Management program will discuss the change in their courses. In addition, a town hall meeting will be held with the students before the end of the spring semester. Incoming students will be emailed, and sent a letter via USPS regarding the changes. Also, this will be discussed in depth with them during the orientation sessions and in AMT 101. We anticipate a very positive response from students as this change better reflects industry standards and hiring practices.

The unit will move all 88 current students to the new degree program once it is established. If the new program is not approved, then we do not want to disestablish the BS in Air Traffic Management degree and the students will continue in the current program. **Applications:**
