**1. The certificate in Program Evaluation will provide students with a solid grounding in the applied and conceptual tools of conducting evaluation research. Professionals in the government, nonprofit and private sectors are increasingly required to demonstrate effectiveness of programs and activities; this certificate program will provide them with the necessary skills to implement evaluations. The program will provide students with a basic grounding in the applied and conceptual tools of conducting program evaluations. It is a less intensive option to the proposed MS in Program Evaluation. The certificate will be an attractive option to students in a variety of degree programs as well as professionals who may have a master degree but would like some expertise in program evaluation. There are thousands of professionals requiring these skills providing a large potential market. There are no comparable programs at ASU, and though not prevalent at other universities there are similar graduate level programs, either master degrees or graduate certificates, at University of Washington (School of Nursing), University of California Berkley (Graduate School of Education), Boston University (School of Education), Tufts University (Arts and Sciences), and University of Connecticut (Educational Psychology). This certificate will compliment many of the other programs at ASU where graduates are likely to engage in program evaluation.

The program will be administered by a committee made up of one faculty member from each of the four schools in the College of Public Programs. The committee will review applicants, admit students, and refer students to the graduate advisor in the school that is the best fit with the student's interests. Advising and administrative support will be provided by the graduate advisor and staff in that school. Students may also select their own faculty advisor as with other graduate programs. All courses for the degree are already offered by the schools and all schools have graduate advisors and support staff.
