Briefly describe the rationale for disestablishment:

The Counseling ~~Education~~ Psychology faculty moved to the School of Letters and Sciences as part of the July 2010 reorganization disestablishing the Mary Lou Fulton Institute and Graduate School of Education. This degree was primarily a Masters in Passing for the Counseling Psychology Ph.D. which also moved to SLS.

Impact on other existing programs: Could include availability of course content for students in other majors who may need it; other.

No impact on students in Teachers College. Faculty in Counseling Psychology ~~or Education~~ are planning to establish an MA in passing their new college, which we support.

Impact on current students: Estimate number of students still enrolled; anticipated date of last graduates; arrangements for continuing students and students in articulated transfer pathways (ex. MAPP, TAG).

There is only one student in the program who will be able finish his/her degree requirements by August 2012. This degree has been closed for applications for a while and was primarily offered as a master's in passing for students in the PhD in Counseling Psychology program. Students currently in this doctoral program who meet the requirements of the master's in passing will be given the chance until August 2012 to get the MEd in Counselor Education
