RE: Proposed establishment of **Oral History Certificate**

Certificate Description:

The Oral History Certificate (OHC) at New College introduces students to the interdisciplinary theories and methods of oral history that enable scholars, students, and practitioners to collect, document, and preserve the stories and memories of people's lives. The certificate will train students to acquire critical knowledge and applied skills, and to abide by the professional standards involved in oral history documentation, research and presentation. Students in the program may build on existing projects or develop new community relationships at local, national, and international levels. Consistent with ASU's mission and New College goals, the certificate fosters an understanding and appreciation of diverse cultures, past and present and engages students in socially embedded and ethical practices in oral history research and interviewing.

Certificate Justification/Need:

The Humanities Arts and Cultural Studies (HArCS) division is organizing the Oral History Certificate as a stand-alone, interdisciplinary program making it more visible and attractive to students from multiple degrees, rather than risking burying it as a concentration within an existing undergraduate degree that may offer too narrow a home, particularly as it can be sought by graduate students, professionals, and students majoring in professional programs. In addition, there is currently no major or existing degree that focuses on oral history as a discipline under which to attach this study; for example, the certificate is not designed to solely serve the purpose of a history degree. While "writing history" will certainly be a component within the courses used to teach students about the theories and methods of oral history, in addition to the applied skills, our purpose is to accommodate students interested in obtaining the knowledge and skills to apply to their respective fields of interest. Because this certificate uses performance as one of the vehicles by which students will be allowed to translate/articulate their respective histories to a public audience, we anticipate that the certificate will also appeal to students in the Documentary Studies Bachelor of Arts degree that HArCS has been given permission to develop for 2012. Finally, interdisciplinarity is a foundational piece of the Oral History Certificate, as participating faculty represent a number of specialties within the Divisions of Humanities, Arts and Cultural Studies and Social and Behavioral Sciences in New College, and units across the university.

Admission Requirements:

The certificate in Oral History is open to any student admitted to study at Arizona State University. The certificate program is also available for graduate students, non-degree students and students majoring in professional programs. Contact advisors in the Division of Humanities, Arts and Cultural Studies for admission to the certificate program.

Oral History Certificate requirements:

Students must meet with the program academic advisor to review the requirements and sign the certificate check sheet. The student should also consult with an academic advisor in the college or department of his or her major to make sure the college or department of the major recognizes the certificate. All course work in the program must be completed with a grade of "B" (3.00) or higher.

Total Credit Hours: 18 credit hours

Residency Requirement:

Of the 18 upper-division credit hours required for the certificate, 12 credit hours must be completed at ASU.

I. Core Requirements: (6 credit hours)

- 1. ETH 310, Critical Research Methods (name change from ETH 310 Research Methods in Race, Ethnicity, and First Nations Studies submitted in ACRES) (3 credit hours)
- 2. AMS 498, Pro-Seminar (3 credit hours)

II. Current Course Bank: (12 elective credit hours)

The course bank includes upper-division (300-400 level) courses offered across the university. Students may choose from the following prefixes: American Studies (AMS), English (ENG), Ethnicity, Race and First Nation Studies (ETH), History (HST), Interdisciplinary Arts and Performance (IAP), Integrative Studies (IAS), Philosophy (PHI), Religion (REL), Sociology (SOC), Spanish (SPA), and Women and Gender Studies (WST), upon approval by appropriate faculty or advisor. III. New Courses to be proposed at a later time:

Administration of Certificate:

Projection of student enrollment: Student enrollment is expected to reach 30 by the end of the third
year. We will aggressively market this certificate to students in both the HArCS and SBS divisions in
New College, to students at the other campuses in relevant programs, and to libraries, businesses and
community activist organizations in the Valley.

Requirement of new courses: Most courses are currently housed within New College, with the exception of ENG 412 which is in the Tempe English course bank, and ENG 344, ENG 376 and ENG 377 offered at Polytechnic; we will seek permission for inclusion of ENG 412 in our course bank. ENG 394 (Scriptwriting) has been taught as a Special Topics course for six years with continuously high enrollment, and is being proposed with its own discrete course number.

- The certificate will be administered by the faculty and advising staff in the division of Humanities, Arts and Cultural Studies. Students will apply to the certificate program and will then be tracked through to completion. The procedures for processing the Oral History certificate will be consistent with established certificate offerings and processes within New College.
- Budgetary requirements: No additional permanent resources are required to launch this certificate.
- Student recruiting funding and staffing: No new resources will be required for recruitment. The current recruiting staff in New College will add the Oral History certificate to their offerings.

Impact Statements for the Oral History Certificate

In addition to the responses below, I also wrote requests for impact statements to: Donald Fixico, Sybil Thornton, Jannelle Warren-Findley, and Karen Leong. Prof. Thornton replied directly to the committee with some concerns about the use of the terms "oral history" and "oral tradition." This issue is one of the first we address in our oral history methodology course. We also problematize and expose students to different versions of the" history of oral history" for them to consider, incorporating into their readings writings from indigenous scholars' points of view as well as more mainstream interpretations of the field. While this may not be oral history as understood by historians, it is because we are not creating this certificate to serve solely historians, but rather, a broad interdisciplinary base of students.
