This social science certificate program prepares students to acquire, manage, and analyze a broad range of data on human thought and human behavior, leveraging an array of qualitative and quantitative methods. Data acquisition skills may include the downloading and managing of information from online sources or the primary collection of data such as in surveys or in direct observation. A key feature of this program is a focus on data analysis skills, so graduates will be able to interpret properly any data that they can collect. The certificate provides demonstrated general competencies in statistical analysis relevant to any social research, plus skills in a selection of methods relevant to identified fields of enquiry.

Dear Duane:

Thank you for the quick turnaround on our proposal. We found an error in the proposal and have been asked to send it around again, with the change. There are two required, 3-credit courses in the the 18 credit certificate program: a course on multivariate statistics (or the equivalent) and a capstone course in which the student desigtns and carries out a research project. We had included, in error, the option of taking an introductory course in statistics instead of the course on multivariate stats. That error is fixed in the attached.

The course in multivariate statistics can be taken in any unit, but will be taught regularly by new faculty hires coming on this year. The rest of the courses in the certificate program are drawn from research methods courses offered by academic units across ASU. The certificate will be housed in the School of Human Evolution and Social Change but will comprise courses from any school offering advanced social science methods courses.

This is to request your approval and support for the new certificate. You can find a preliminary list of undgraduate courses on social research methods <u>HERE</u>. This is just a sample list. Thank you for suggesting other courses that can be added to the menu and please let us know if there are any new methods courses developed in your college in the future.
