The certificate includes courses in political science, economics and other academic areas that relate to politics and the economy. Students majoring in any subject at the university may be awarded the certificate upon completion of 15 credits (12 credits must be upper-division and nine of these upper-division credits must be taken from the College of Liberal Arts and Sciences).

ASU has recently approved a Politics and the Economy concentration which is affiliated with the BS degree in Economics (offered via CLAS). ASU already has minors in Economics and Political Science. A minor is usually comprised of courses in one discipline whereas a certificate is an academic program that may combine courses from many disciplines to focus on a topic. The Political Economy certificate examines the intersection between economics and politics. Thus we have developed this certificate to provide students the opportunity to take courses in both political science and economics as well as in related disciplines which focus on salient issues related to the intersection of the disciplines of politics and economics.

### D. Affiliation

The Political Economy certificate will serve our undergraduate students who plan to pursue career interests in politics, economics and public policy. The curriculum will provide students the opportunity to establish a baseline knowledge of politics, government, political and economic theory as it relates to political issues and to the economy in general.

ASU has recently approved both a BS in Politics and the Economy and a concentration in Politics and the Economy that is associated with the BS in Economics (CLAS). Students pursuing these academic programs will need to have a significant preparation in calculus and advanced economics. The certificate provides students an option to complete courses that focus on the juncture of politics and economics without the added necessity for knowledge of advanced mathematical and economic concepts.

## E. Demand

ASU has a new Center for the Study of Economic Liberty that is hiring political scientists and economists to offer advanced study of the juncture between politics and economics. The Political Economy certificate will help fill this interdisciplinary demand.
