Briefly describe the rationale for disestablishment:

The Urban Studies concentration of the Bachelor of Science in Geography program has seen continued decline in enrollment over the past three years. Full-time enrollment in Spring 2017 is down 50 percent as compared to Spring 2016 and down 66 percent as compared to Fall 2014. Students interested in focusing on the topic of urban geography can still do so under the Geography BS degree program with the help of academic advisors with course selection. Such students will also be encouraged to expand their course of study with the Urban Planning minor, a highly related subject, to promote interdisciplinry study within the school.

The disestablishment Urban Studies concentration of the Geography BS program is in-line with the vision and mission of the School of Geographical Sciences and Urban Planning to promote interdisciplinary study across the SGSUP disciplines. The Urban Studies concentration was established prior to the 2009-10 merger of the Geography BS and the Urban Planning BSP programs. It therefore creates artificul separation between the SGSUP disciplines instead of promoting interdisciplinary study. The disestablishment of the Urban Studies concentration will promote interdisciplinary study across SGSUP disciplines by encouraging Geography BS students who want a deeper understanding of the urban environment to minor in Urban Planning.

Impact on other existing programs:

It is expected that the disestablishment of the Urban Studies concentration will have no significant impact on existing programs. The coursework that constitutes the Urban Studies concentration will still be offered by the School of Geographical Sciences and Urban Planning under the general Geography BA and BS programs.

There are currently five (5) Geography (Urban Studies) BS majors enrolled in the current Spring 2018 semester. Two of these students will be graduating in May 2018. The three remaining students will be entering their second Junior semester in Fall 2018. It is expected that they should graduate with the existing urban studies concentration by Spring 2020. Six students have applied to the Geography (Urban Studies) BS program for the Fall 2018 semester. These students will be advised regarding the disestablishment of the program and it will be recommended they change majors to the Geography BS program.
