Briefly describe the rationale for disestablishment:

The certificate in Southeast Asian Studies duplicates what is offered by the certificate in Asian Studies; students can accomplish the same objectives and complete the same courses through the Asian Studies certificate, but the Asian Studies certificate offers even more course choices. In addition, both the Southeast Asian Studies certificate and the Asian Studies certificate have had low enrollment, so maintaining only one of these two certificates reduces the administrative efforts needed.

Impact on other existing programs:

May include availability of course content for students in other majors who may need it; other.

There is one active student currently enrolled in the certificate. That student will still be able to complete the certificate because the necessary courses are still offered. There are no transfer pathways for certificate programs, so there should be no impact there. Any transfer student who was planning to pursue the Southeast Asian Studies certificate will be able to pursue the Asian Studies certificate instead (LAASNCERT).

Impact on current students:
