## Briefly describe the rationale for disestablishment:

In the past few years, enrollment in the Certificate in Writing program has steadily declined, and there are now just four students enrolled. The resources required to administer this program can not be justified given this small size, as it takes time and attention away from other programs that are more attractive to students. We believe the certificate program may be less attractive to some students than the department's undergraduate Writing Rhetoric and Literacies concentration and major, which is a robust and well-developed academic program for students interested in studying writing.
