#### 1. OVERVIEW

Established in 2006, the School of Sustainability was the first to offer degrees not only at Arizona State University but in the nation. Since then the inclusion of sustainability in academic courses and programs has grown exponentially. On the undergraduate level, students can add sustainability to their course of study through the Sustainability Undergraduate Minor. Currently, there is nothing available for graduate students who would like to explore Sustainability and how it applies to their preferred area of study at the graduate level. A graduate certificate in Sustainability will allow students at the graduate level to explore and incorporate these important concepts. Students will be able to pursue the certificate while concurrently enrolled in a graduate degree program at ASU or as a standalone certificate that can benefit them professionally.

Currently there are more than 20 graduate programs that incorporate sustainability in some way at Arizona State University, outside of the 10 plus programs offered by the School of Sustainability. In addition, courses offered by the school are used as a core part of specializations and draw students from across the university including W. P. Carey School of Business, Herberger Institute for Design and the Arts, Watts College of Public Service and Community Solutions, The College of Liberal Arts and Sciences, and Ira A. Fulton Schools of Engineering. Other programs such as the Thunderbird's Master of Global Management and the Master of Science in Global Technology and Development from the School for the Future of Innovation in Society have expressed interest in incorporating graduate sustainability courses. An existing Graduate Certificate in Sustainability will make this interdisciplinary cooperation easier to achieve.

Sustainability is a major area of job growth. Many organizations, businesses, governments, and agencies are searching for potential employees with some knowledge of sustainability and how to apply it. The target audience for the graduate certificate is any existing graduate student that would like to add a more in-depth study of Sustainability to their existing program. Students who would like to understand the concepts and techniques and how to incorporate those into their areas of specialization will also find this certificate beneficial. Non-degree seeking students will also be interested as it provides them an opportunity to understand the field before embarking on a full degree program. They would also find it useful if they need to add sustainability knowledge as part of their professional development.

The two core courses as well as many of the potential sustainability electives will be designed and offered fully online as both oCourses and iCourses. There will be no significant difference in the courses between those taking them through ASUOnline and those taking them from any of the ground campuses. Students in the ground immersion will take a combination of ground and iCourses as electives to provide some flexibility with the program. This will make the certificate easily accessible to graduate students at all of the current ASU campuses as well as to students through ASUOnline. The potential audience may be difficult to assess but, based on the experience with the



undergraduate sustainability minor, it is expected to achieve high growth as students become aware of it and how it can fit into their current plan of study. There is a demand for employees and leaders who know what sustainability is and understand its complexity, understand how to approach problems and solutions, and know how to work with and draw from different disciplines. By engaging a breadth of knowledge and experience, and by acquiring the skills to integrate various domains of knowledge, sustainability students prepare themselves for a variety of careers. Recent interest in sustainability within business and government has created new employment opportunities – in positions like sustainability coordinators, directors, and managers. Adding a sustainability certificate to their educational portfolio may allow graduates to assume positions in industry, consultancy, utilities, regulatory agencies, nonprofits, governmental agencies and nongovernmental organizations.

Admission and oversight will be done through the processes already established for handling of students and overseeing graduate education in the School of Sustainability. Specifically, SOS's Graduate Committee, which oversees graduate academic programs, will be responsible for reviewing applicants, advising them on course selection, and reviewing and approving course petitions. The chair of the graduate committee will be overseeing the program.

There is adequate support to launch and maintain the certificate. Course content will be delivered by existing faculty.

Developing sustainable solutions depends on interdisciplinary collaboration. The skills developed in this program, like systems thinking and solutions-based problem solving, are essential to addressing sustainability challenges across disciplines. Students in the program will learn to communicate and collaborate with faculty and peers from varied backgrounds, preparing them to lead teams in the future.

The courses in the certificate program introduce students to the foundations of sustainability through a disciplinary overview and problem-solving methodology. Through electives, students can explore specific areas that are of greatest interest. Subjects include policy, international development, clean air and water, sustainable food systems, corporate social responsibility, waste reduction, human rights, climate transformation, and clean energy. The certificate is designed to be taken independently or as a supplement to another graduate degree program.
