Briefly describe the rationale for disestablishment:

It was determined that the current state of the certificates is very narrowed (language focused), and alienates many students interested in medieval and renaissance studies who are not focusing on language—for example, students of medieval and early modern art history, English literature, etc. Continually, many of the core class requirements are simply not offered on a consistent enough basis to guarantee a student will be able to take it during their time at ASU.
