# PROPOSAL TO CHANGE THE NAME OF AN ACADEMIC PROGRAM (Degree, Concentration, Certificate, Minor)

#### Briefly describe the proposed change and rationale for the change:

The goal of this name change, along with changes to program requirements, is to help corrections officers in all branches of the field (jails, prisons, halfway houses, probation, and parole) to change the traditional ways in which they do their jobs from a reactive framework into one that focuses on transformational leadership, team building, motivation, and collaboration with employees at all different levels of an organization. The need for responsible and innovative leadership in this field is intrinsically tied to various calls for reform in corrections facilities throughout the nation.

According to the Bureau of Labor Statistics, career opportunities in corrections are abundant through the local government, state government, facility support services, and the federal government. Overall, occupations in corrections are anticipated to grow at a rate of three percent, resulting in 3,000 new jobs by 2028 (Bureau of Labor Statistics, 2019). Payscale estimates the median national salary for senior corrections officers with security policies and procedures skills to be at \$45,777, with a range between \$34,000 and \$91,000. This certificate provides students with the skills and credentials necessary to prepare them for a career as correctional professionals. Graduates of this certificate program may be particularly competitive applicants for employment within corrections institutions at the local, state, and federal level. Purdue University, The University of Oklahoma and Missouri Southern State University all offer graduate-level certificates in Corrections Leadership and Management. The certificate programs generally range between 12-18 credits.

#### Discuss the impact of this change on current students and/or enrollment:

We anticipate no change to current students. This change may entice more students to enroll in subsequent academic years. The college will have a plan to notify existing students and applicants that the program is going through ASU governance with a name change. Summer 2021 will be the last time students can compete the program with the old name. Starting Fall 2021, students will complete the program under the new name.
