(note: the verbiage regarding "quarters" has also been updated throughout the proposal as requested – an amended proposal is posted on the CAPC website).

CAPC had several concerns regarding this undergraduate concentration in Secondary Education. The main concern was course content, as it relates to the courses included within this concentration.

Dr. Elizabeth Hinde attended the meeting, and informed the committee that she would be happy to discuss course modifications with the School of Historical, Philosophical and Religious Studies. Dr. Hinde advised the committee that this is the second concentration that is available to all students that want to become High School teachers.

After a lengthy discussion, a motion was made to approve this new concentration.
