

ASU Cost Calculator

By entering a few details about your academic and financial status, the cost calculator will give you a close estimate of your costs, including housing and dining. You can also get an estimate of financial aid.

2016-2017 Standard Cost of Attendance

The cost of attendance is the estimated full and reasonable cost of completing a full year as a full-time student and includes

tuition and fees, room and board, books and supplies and other expenses including personal expenses and transportation.

ASU Scholarship Estimator

You can enter your ACT or SAT scores, high school class rank and cumulative competency GPA to determine the level of merit scholarship that you could receive. (Competency GPA is the GPA earned on competency courses.

Student Budget Worksheet

Create an annual budget using our student budget worksheet that itemizes direct costs (like books, housing, food) and other costs (like a parking permit or bus pass).

Applying for financial aid

For most types of financial aid, you will need to complete the Free Application for Federal Student Aid (FAFSA). There is no charge for submitting the FAFSA, and you can find more information at fafsa.ed.gov.


ASU's federal school code is 001081.
