a. Additional information and notes:

The study examines types and amount of bacteria in stools of individuals with and without autism, (4 populations are recruited: autistic with major gastrointestinal issues, autistic with minor gastrointestinal issues, non-autistic with major gastrointestinal issues and non-autistic with minor gastrointestinal issues.)The study is funded by a gift to ASU from the Bhare Foundation. The researchers proposed to enroll 70 participants ages 3-17. At the last review, researchers had enrolled a total of 17 participants (8 autistic and 9 controls). No new participants were enrolled this review period, researchers focused on data analysis. Discussion included the assent process for autistic children.

The purpose of this project, funded by the American Heart Association, is to test the effectiveness of a child physical activity and nutrition program, "Athletes for Life", delivered in a local City Recreation Center. This study is a twelve week program for adults and children. Study procedures include blood draws, DEXA measurements, fitness testing and activity monitoring.

The IRB determined that the research was permissible under 45CFR46.405 for research involving greater than minimal risk but presenting the prospect of direct benefit to the individual child subjects with parental permission and child assent.
